Dear Property Owner:

Vertical Bridge is proposing to install a wireless telecommunication facility within the public right-of-way near F/O Greenbriar Dr-Mulholland Drive. Please see the attached photo simulation for a detailed view of how the proposed above ground facility will look. The above ground facility consists of above ground equipment that will support the wireless facility, which will enhance the wireless coverage and capacity in the surrounding area.

The City of Los Angeles requires that notifications be sent to property owners and residents adjacent to the proposed facility so that they may provide input regarding the application. They also require that the local City and Neighborhood Council be notified. You may direct any concerns you have prior to or during construction to the Bureau of Engineering. You may also contact Melissa Keith at [mkeith@assurance-group.com](mailto:mkeith@assurance-group.com).

Under California Public Utilities Code Sections 7901 and 7901.1, Vertical Bridge has statewide franchise rights, which allows placement of equipment in the public right-of-way. Local governments are limited in regulating the time, place, and manner of access and may not simply deny use of the public right-of-way by a utility company.

Section 704 of Title 7 of the Federal Telecommunications Act of 1996 contains the following language: “No state or local government or instrumentality thereof may regulate the placement, construction, and modification of personal wireless service facilities on the basis of environmental effects of radio frequency emissions to the extent that such facilities comply with the Commission’s regulations concerning such emissions.”

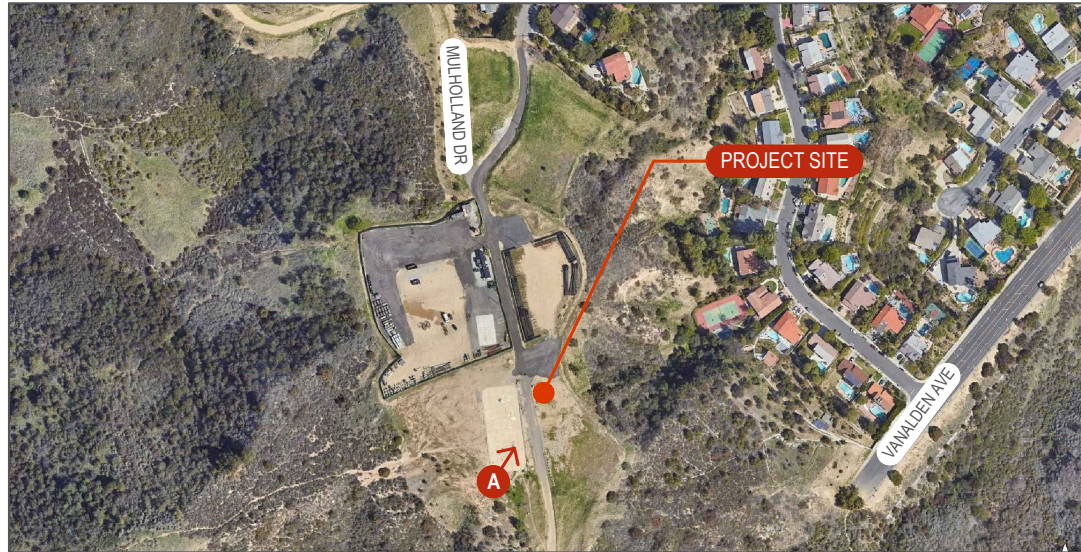

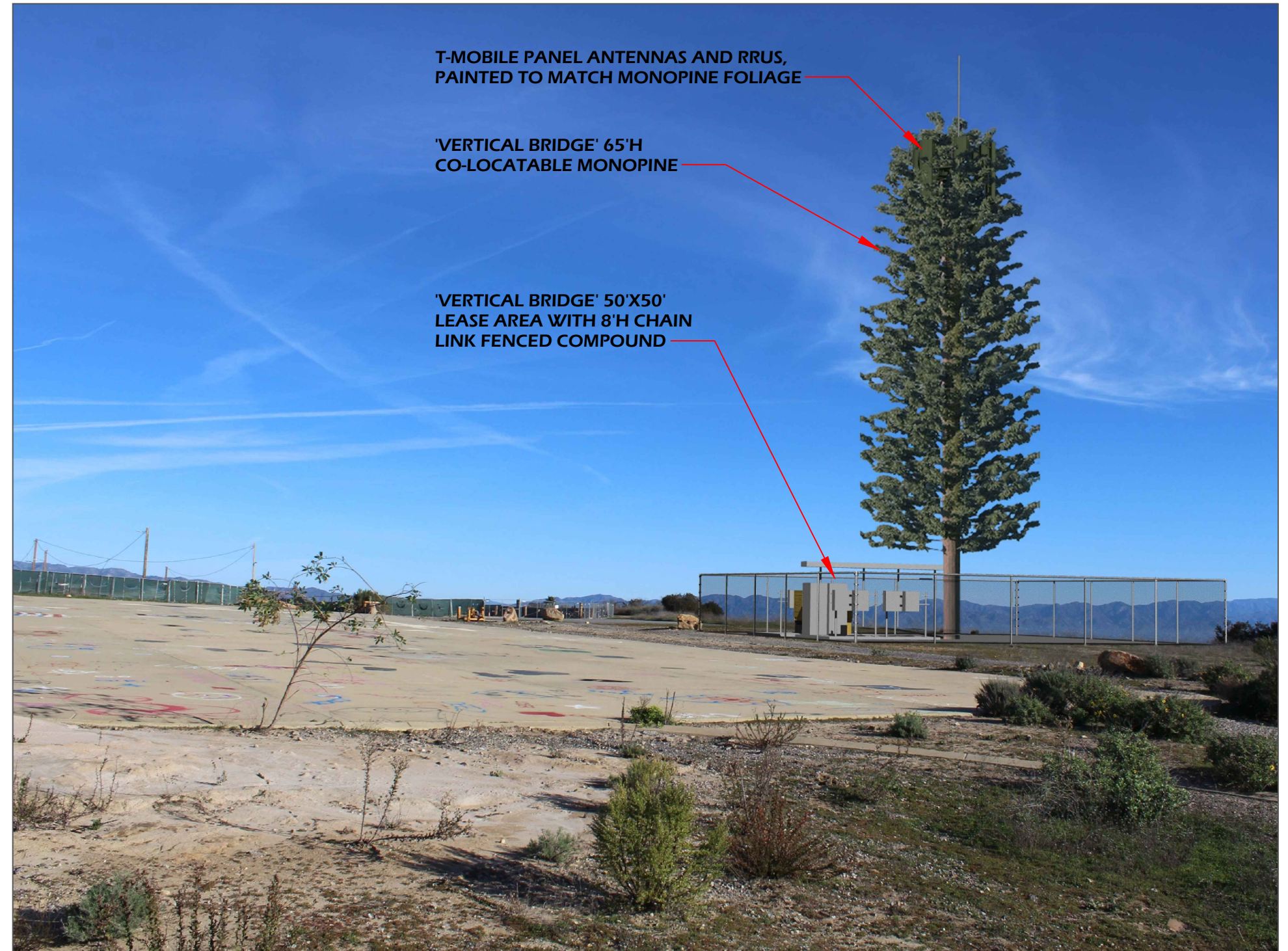

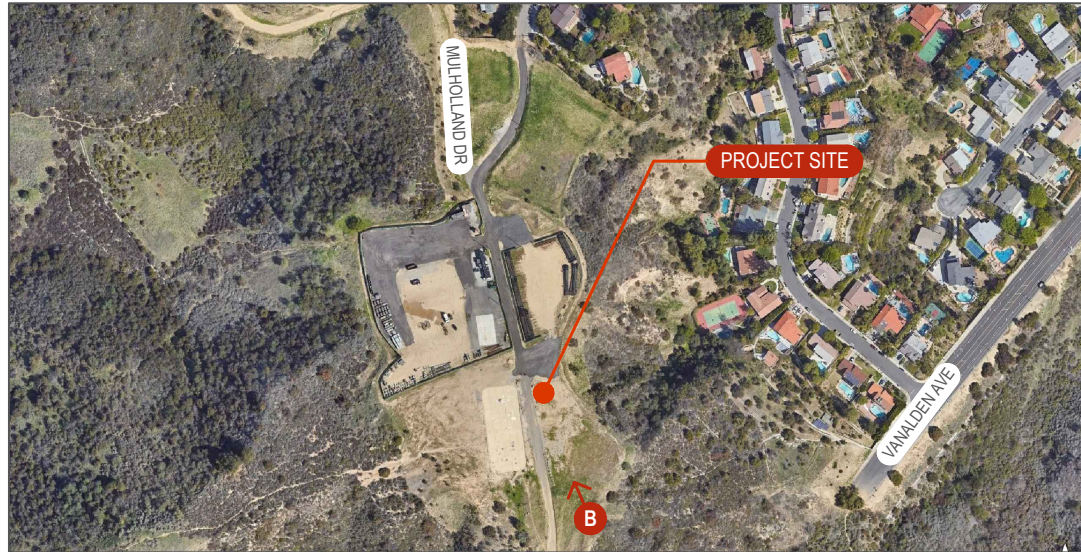
