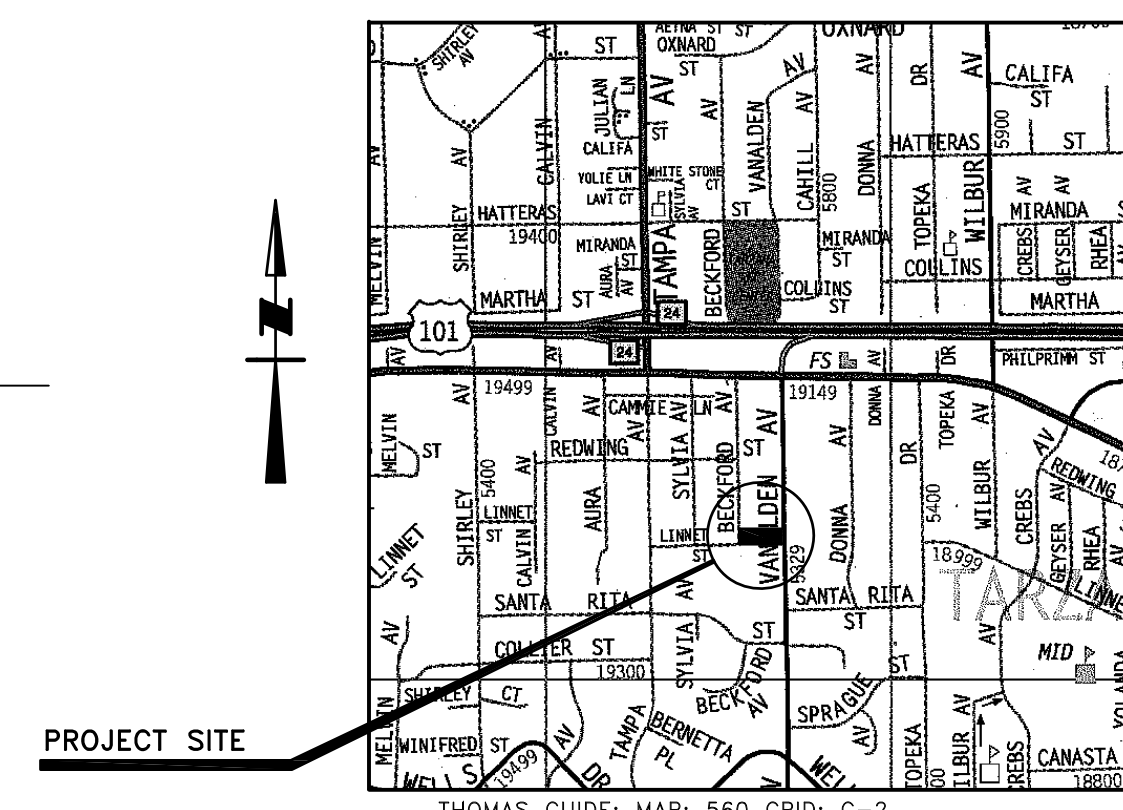
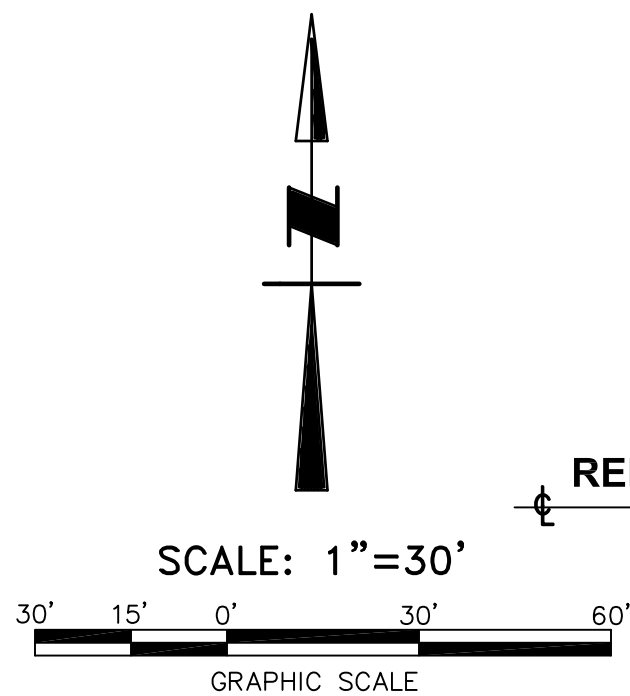


TENTATIVE PARCEL MAP NO.

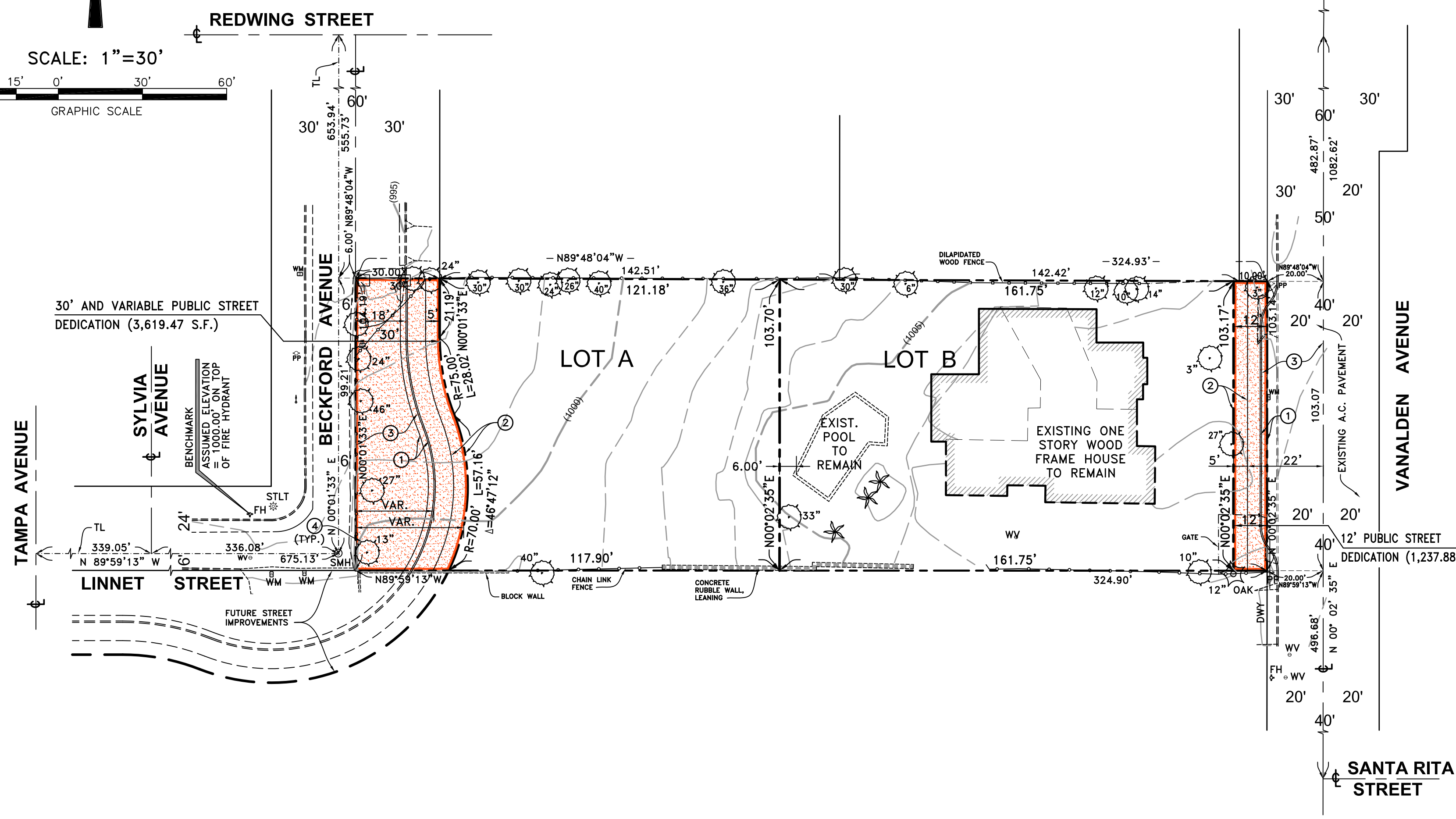
BENCHMARK:

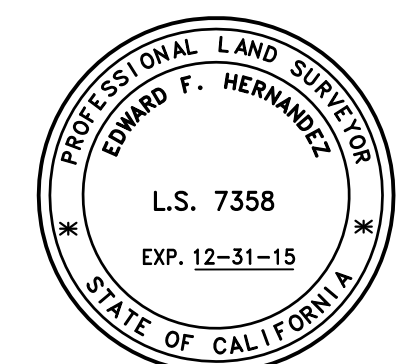
