The public is requested to fill out a “**Speaker Card**” to address the Board on any item of the agenda prior to the Board taking action on an item. Comments from the public on Agenda items will be heard only when the respective item is being considered unless a board member requests that it be called out of order. Speakers shall limit their comments to matters relevant to the item on the agenda. The Chair may rule that the speaker is out of order if the comments are not germane to the item under consideration. If multiple speaker cards are submitted on one agenda item, preference will be granted to members of the public who have not spoken previously during the meeting, either during public comment or on another agenda item.

Comments from the public on other matters not appearing on the Agenda that are within the Board’s subject matter jurisdiction will be heard during the Public Comment period. Public comment is limited to 2 minutes per speaker, unless waived by the presiding officer of the Board.

3. Public Comments – Comments from the public on non-agenda items within the Committee’s subject matter jurisdiction. Public comments are limited to two minutes per speaker.
4. Discussion & Motion: Approval of minutes from October 10, 2019 meeting.
5. Motion to adopt the following general goals and objectives: To serve our homeless community and assist Los Angeles Housing Services Authority (LAHSA) and LA City in reaching out to the homeless in Tarzana and neighboring communities by sponsoring on a regular basis different events e.g. the collection and distribution of the following: food, hygiene kits, clothing, and resume critiquing. Heighten awareness of the monthly *Connect Day* among the homeless community through TNC publicity committee, word and mouth and flyers. Designate an outreach person who will be our liaison to other neighborhood councils. Designate a media person who will collect info on homelessness around town and through news medias and give us monthly updates. Designate a homelessness policy advocate who will spotlight, report on and advocate legislation moving through the system and keep the committee updated.
6. Discussion and motion: Write up flyer for 'Emergency Winter Shelter Program,' program runs for appx. 4 months. It serves homeless adults 18 and over. The flyer would include hot line phone number 800-548-6047/211 or visit web site at [www.lahsa.org](http://www.lahsa.org), time open (LAHSA says to call on Dec. 1) for duration, basic requirements and list of services offered: (emergency shelter, showers, meals and program location, provide access to supportive services and housing assistance.) Facilities are opened between 5pm and 7am, applicants must call for accommodations, no walk-ins.
7. Discussion: Purchase tokens so that Tarzana's Homeless that are without transportation may attend monthly Connect Day. Identify potential Safe Parking location within the perimeter of Tarzana (Linley- Corbin, Victory-Mulholland).
8. Discussion: publicity - how can we heighten awareness of the Tarzana Homelessness Committee.
9. Committee Business - Comment from Board members on subject matters within the Board's

jurisdiction.

- a. Comment on Committee members own activities/brief announcements.
  - b. Brief response to statements made or Questions posed by persons exercising their general public comment rights.
  - c. Introducing new issues for consideration by the Committee at it's next meeting and to request they be considered for the next Committee agenda.
