IN CONFORMITY WITH THE OCTOBER 6, 2023 ENACTMENT OF CALIFORNIA SENATE BILL 411 (PORTANTINO) AND LA CITY COUNCIL APPROVAL ON NOVEMBER 1, 2023, THE TARZANA NEIGHBORHOOD COUNCIL'S EXECUTIVE COMMITTEE MEETING WILL BE CONDUCTED VIRTUALLY.

## SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall

not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

Public Comment: Every person wishing to address the Committee must dial (1-669) 900-6833 and enter 843 9758 7781 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the committee meeting the public will be requested to dial \*9 or use the Raise Hand option, to address the Committee on any agenda item before the Committee takes action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

General Public Comment: Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Committee meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Committee.

Public comment cannot be required to be submitted in advance of the meeting; only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Committee's control, the meeting must be recessed or adjourned.

Any messaging or virtual background is in the control of the individual Committee member in their personal capacity and does not reflect any formal position of the Committee, the Neighborhood Council or the City of Los Angeles.

The Tarzana Neighborhood Council Animal Welfare Committee (TNC AWC) requests that the TNC Board pass a resolution stating that the Tarzana Neighborhood Council supports the SISTER CITY/STATE PROJECT TO END DOG AND CAT MEAT IN VIETNAM. Since 2019, it has been the official position of the City of Los Angeles to oppose dog meat, including specifically in the country of Vietnam. On September 10, 2023, President Biden and the leader of Vietnam entered into the Joint Leaders' Statement: Elevating United States-Vietnam Relations To A Comprehensive Strategic Partnership. The Joint Leaders' Statement encourages states and cities in the United States and Vietnam to enter into sister city/state relationships. Since it is the official position of Los Angeles to oppose dog meat in Vietnam, the city that Los Angeles enters into a sister city relationship with should ban dog and cat meat. The SISTER CITY/STATE PROJECT TO END DOG AND CAT MEAT IN VIETNAM will offer a city or province in Vietnam a sister city/sister state relationship with Los Angeles and/or California, which would be conditioned on the Vietnam city or province banning dog and cat meat. This resolution supporting the SISTER CITY/STATE PROJECT TO END DOG AND CAT MEAT IN VIETNAM shall be communicated to the City Council and other relevant City agencies. This resolution can be filed as a Community Impact Statement in support of any City Council resolution on this subject. The Tarzana Neighborhood Council Animal Welfare Committee (TNC AWC) requests that the TNC Board pass a resolution stating that the Tarzana Neighborhood Council supports sufficient funding for spay/neuter, including sufficient funding for spay/neuter vouchers and sufficient personnel in the Animal Services Department to enforce spay/neuter laws. This resolution shall be communicated to the City Council and other relevant City agencies. This resolution can be filed as a Community Impact Statement in support of any City Council resolution on this subject.
